## SECTION 6: ACCIDENTAL RELEASE MEASURES

---

**SPILL MANAGEMENT:** Eliminate all sources of ignition in the vicinity of the spilled material. Stop the leak if safe to do so. Contain and absorb with suitable absorbent material.
